B. Cases Decided and/or Disposed of:

3-day suspension

withdrawal

Kansas Commission of Veterans' Affairs Office, Kansas Veterans Home Certified Nurse Assistant. Appellant received a 3-day suspension for performing her duties in a brutal manner by slapping a patient's arm. Before the prehearing conference, appellant withdrew her appeal. **Dismissal** default

Kansas Department for Aging and Disability Services, Larned State Hospital Mental Health Developmental Disability Technician. Appellant was terminated for insubordination by failing to follow a request by a supervisor. A prehearing conference was scheduled. Appellant did not timely appear. Later, she called and was advised that a Proposed Default Order was issued and that she would have to respond. She did not respond.

Reprimand/Whistleblower

Department of Corrections, Larned Correctional Mental Health Facility

Classified Investigator. Appellant received a reprimand for failing to conduct himself in a professional manner involving an incident regarding his deactivation of an employee's facility cellphone and his subsequent investigation which the facility deemed was retaliatory. After the prehearing conference, appellant withdrew his appeal.

3-day suspension

Corrections Officer I. Appellant received a 3-day suspension for making an inappropriate and unprofessional comment to another employee while on duty. Prior to the hearing, appellant did not provide any of the required documents to the Board. She was contacted by letter asking her to advise the Board whether she was going to appear for her hearing. The letter specifically provided that her failure to contact the Board would be deemed a withdrawal of her appeal. She did not contact the Board so her appeal was deemed to be withdrawn.
