Re: Quarterly Update

The following reflects the Civil Service Board case filings and action taken since the July 16, 2014 quarterly report:

A. Cases Filed Between July 15, 2014 and October 15, 2014:

B. Cases Decided and/or Disposed Of:

**Dismissal** dismissed

Department for Children and Families

Human Services Specialist. Appellant was dismissed for forwarding and initiating instant messages that contained inappropriate content, some of which were of a sexual nature. A prehearing conference was convened during which deadlines were established by agreement of the parties. A prehearing order was issued memorializing the deadlines. Thereafter, appellant did not comply with the deadlines. DCF filed a motion to dismiss. Appellant was given a deadline to respond to the motion. She did not respond, so the case was dismissed.

**Dismissal** withdrawn

Kansas School for the Blind

Registered Nurse Senior. Appellant was dismissed for failing to maintain a harmonious and collaborative relationship with her supervisor. Appellant withdrew her appeal.

**Demotion** affirmed

Department of Corrections-Kansas Juvenile Correctional Complex

Juvenile Corrections Officer III. Appellant was demoted to a Juvenile Corrections Officer II as the result of excessive tardiness, leaving early, and providing inaccurate time on his time records. The Board affirmed the decision of the appointing authority.

## Proposed promotion to unclassified service

dismissed

Department of Administration-Printing Plant

Maintenance Supervisor. Appellant was offered a promotion to an unclassified position as the Maintenance Supervisor at the Printing Plant; he declined to accept the offer. Appellant filed an appeal. The agency filed a motion to dismiss on the grounds that the Board did not have jurisdiction to hear the appeal. Appellant filed a response. The Board granted the agency's motion and dismissed the case for lack of jurisdiction.

<u>**Demotion**</u> default

Department of Corrections-Lansing Correctional Facility

Corrections Specialist I. Appellant was demoted for failing to follow proper procedures and for his actions during a confrontation with a subordinate. A prehearing conference was scheduled; Appellant did not appear. A proposed default order was issued for his failure to appear to which he did not respond.

<u>Dismissal</u> affirmed

Department for Aging and Disability Services-Parsons State Hospital and Training Center Mental Health Developmental Disability Technician. Appellant was dismissed for hitting a resident on the head. The Board affirmed the decision of the appointing authority.

**Dismissal** dismissed

Department for Children and Families

Human Services Assistant. Appellant was dismissed for excessive tardiness, use of unauthorized/unscheduled leave, displaying inappropriate, insulting, demeaning, or threatening behavior in the workplace, and passive aggressive behavior in the workplace that was inappropriate, unprofessional, and did not contribute to a positive work environment. The parties reached a settlement and the appellant voluntarily dismissed his appeal.

**Resignation** dismissed

Department of Corrections-Topeka Correctional Facility

Corrections Officer I. Appellant filed an appeal regarding whether his resignation from the Topeka Correctional Facility was fair. The agency filed a motion to dismiss on the grounds that the Board did not have jurisdiction to hear the appeal. Appellant responded to the motion. The Board granted the agency's motion and dismissed the case for lack of jurisdiction.
