Re: Quarterly Update

The following quarterly report reflects the Civil Service Board case filings and action taken between January 15, 2016 and April 15, 2016:

A. Cases Filed Between January 15, 2016 and April 15, 2016:

Disqualification for safety sensitive positions for one year, Department of Administration, filed February 4, 2016

Dismissal, Kansas Highway Patrol, filed February 10, 2016

Disqualification for safety sensitive positions for one year, Department of Administration, filed February 18, 2016

Dismissal, Department of Transportation, filed February 26, 2016

Dismissal, Department for Children and Families, filed March 10, 2016

B. Cases Decided and/or Disposed of:

Dismissal withdrawal

Social Worker-Department for Aging and Disability Services-Larned State Hospital Appellant was dismissed from her position as a Social Worker for allegedly screaming at and striking a patient. Appellant withdrew her appeal on the grounds that Larned had withdrawn the proposed dismissal.

Disqualification for safety sensitive positions for one year

dismissed

Department of Administration

Appellant had had discussions regarding applying for a position at KNI. Appellant claimed that after considering the position, he determined he was not interested and, therefore, did not appear for the required drug screening. In accordance with K.A.R. 1-6-32 and K.S.A. 75-4362, the appellant was disqualified for safety sensitive positions for one year for failing to appear for a drug screen. Appellant claimed he did not appear since he was not going to take the position. After the prehearing conference, the appellant filed a motion to dismiss on the grounds that the parties had reached an agreement. The case was dismissed.

<u>Dismissal</u> withdrawal

Corrections Officer II, Department of Corrections-Winfield Correctional Facility Appellant was dismissed for soliciting another employee to trade with or purchase prescription pain medications from him. After the prehearing conference, the appellant withdrew his appeal.

Disqualification for safety sensitive positions for one year

affirmed

Department of Administration

Appellant was offered a "conditional offer of employment" after passing the Corrections Officer I test interview. In accordance with K.A.R. 1-6-32, the appellant had to pass a drug screening test but failed the drug screening test, testing positive for marijuana (TSC). He also admitted to the drug use approximately two weeks prior to the test. Accordingly, the appellant was disqualified for safety sensitive positions for one year. The Department of Administration filed a motion for summary judgment. Appellant was given an opportunity to respond but failed to do so. The Board granted the motion for summary judgment affirming the decision of the Director of Personnel Services.

<u>Dismissal</u> dismissed

Storekeeper Specialist, Department of Corrections-Kansas Correctional Industries
Appellant was dismissed for admittedly bringing his cell phone, cigarettes, lighter, and a spring loaded knife into the facility. He also admitted to having inappropriate conversations with inmates. A prehearing conference was convened during which deadlines were established by agreement of the parties. A prehearing order was issued memorializing the deadlines. Thereafter, the appellant did not comply with the deadlines. The KCI filed a motion to dismiss for failing to comply with the prehearing order and a motion for summary judgment. Appellant was given an opportunity to respond but failed to do so. The Board granted the motion to dismiss rendering the motion for summary judgment moot.
