Kansas State Gaming Agency

Enforcement Agent. Appellant received a 1-day suspension for responding in an unreasonable manner to a reasonable request of his direct supervisor. The appeal was untimely filed, so the case was dismissed.

Dismissal affirmed

Kansas Department of Aging and Disability Services-Rainbow Mental Health Facility Registered Nurse-Senior. Appellant was dismissed after receiving two unsatisfactory evaluations within 180 day period. The Board affirmed the decision of the appointing authority dismissing the appellant.

3-day suspension/Dismissal

Department of Health and Environment, Bureau of Environmental Remediation

Research Analyst II. Appellant was suspended for 3 days for unprofessional conduct and failing to maintain harmonious work relationships with fellow employees. She was subsequently terminated after receiving two unsatisfactory evaluations within 180 day period. During the hearing, the parties reached a settlement in which the appellant's termination was changed to a resignation.

3-day suspension dismissed

Board of Nursing

Senior Administrative Assistant. Appellant received a 3-day suspension for being rude and disrespectful to a customer. A prehearing order was entered setting forth deadlines agreed to by the parties. Appellant did not comply with one of the deadlines. The Board of Nursing filed a motion to dismiss. Appellant was given a deadline to respond to the motion. She did not respond so the case was dismissed.

2-day suspension withdrawn

Kansas State Gaming Agency

Enforcement Agent. Appellant received a two day suspension for engaging in conduct with the purpose of inciting other employees. Appellant withdrew his appeal.
