Appellant received a three day suspension for using a racial or ethnic slur while on duty. Prior to the prehearing conference, appellant withdrew the appeal.

3-day suspension withdrawal

Parole Office I, Department of Corrections, Parole Services Division Appellant received a three day suspension for using profane language while on duty. Prior to the prehearing conference, appellant withdrew the appeal.

<u>Dismissal</u> dismissed

Appellant was dismissed for alleged misconduct including the trafficking of contraband and providing confidential information to inmates. A prehearing conference was held at which time several deadlines were established. Appellant failed to comply with the deadlines. LCF filed a motion to dismiss on the grounds that appellant failed to comply with the prehearing order. Appellant was given an opportunity to respond but failed to do so. The Board granted the motion to dismiss as unopposed.
