

A RESOLUTION OF THE HUTCHINSON RECREATION COMMISSION, LOCATED IN HUTCHINSON, KANSAS TO LEVY A PROPERTY TAX RATE EXCEEDING THE REVENUE NEUTRAL RATE;

WHEREAS, the Revenue Neutral Rate for the Hutchinson Recreation Commission was calculated as 3.374 mills by the Reno County Clerk; and

WHEREAS, the budget proposed by the Governing Body of the Hutchinson Recreation Commission will require the levy of a property tax rate exceeding the Revenue Neutral Rate; and

WHEREAS, the Governing Body held a hearing on August 29, 2022 allowing all interested taxpayers desiring to be heard an opportunity to give oral testimony; and

WHEREAS, the Governing Body of the Hutchinson Recreation Commission, having heard testimony, still finds it necessary to exceed the Revenue Neutral Rate.


NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE HUTCHINSON RECREATION COMMISSION:

The Reno County may levy a property tax rate exceeding the Revenue Neutral Rate of 3.374 mills.


This resolution shall take effect and be in force immediately upon its adoption and shall remain in effect until future action is taken by the Governing Body.
