A RESOLUTION OF THE USD 210 RECREATION COMMISSION, HUGOTON, KANSAS TO LEVY A PROPERTY TAX RATE EXCEEDING THE REVENUE NEUTRAL RATE;

WHEREAS, the Revenue Neutral Rate for the USD 210 RECREATION COMMISSION was calculated as 4.726 mills by the Stevens County Clerk; and

WHEREAS, the budget proposed by the Governing Body of the USD 210 RECREATION COMMISSION will require the levy of a property tax rate exceeding the Revenue Neutral Rate; and

WHEREAS, the Governing Body held a hearing on September 7, 2022 allowing all interested taxpayers desiring to be heard an opportunity to give oral testimony; and

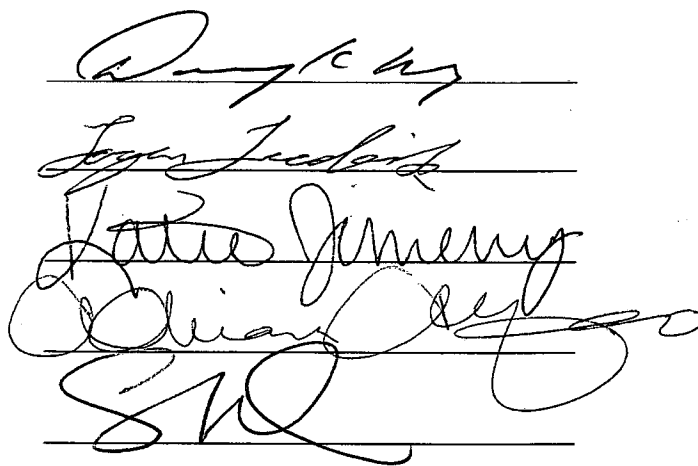
WHEREAS, the Governing Body of the USD 210 RECREATION COMMISSION, having heard testimony, still finds it necessary to exceed the Revenue Neutral Rate.

NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE USD 210 RECREATION COMMISSION:

The USD 210 RECREATION COMMISSION shall levy a property tax rate exceeding the Revenue Neutral Rate of 6.831 mills.

This resolution shall take effect and be in force immediately upon its adoption and shall remain in effect until future action is taken by the Governing Body.

ADOPTED this 7th day of September, 2022 and **SIGNED** by the Governing Body.

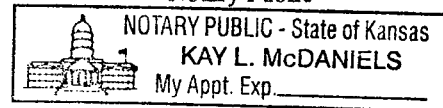
