

RESOLUTION NO. 2024-27

A RESOLUTION APPROVING BUDGET AMENDMENTS FOR CERTAIN FUNDS AS AUTHORIZED BY KANSAS STATUTES ANNOTATED

WHEREAS, the City is required by Kansas law to adopt a budget every year; and

WHEREAS, the City is authorized to amend such budgets for fluctuations in certain funds from time to time; and

WHEREAS, in order to adopt budget amendments the City must first hold a public hearing; and

WHEREAS, the City wishes to amend the 2024 budget for the Sewer Fund, Solid Waste Fund, Bond & Interest Fund, and the Mayor's Charity Fund; and

WHEREAS, a public hearing for the 2024 budget amendments was properly noticed for and held on December 11, 2024; and

WHEREAS, the City now wishes to adopt the 2024 budget amendments for said funds as reflected on the Summary of Amendments, attached as Exhibit A.

NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE CITY OF BASEHOR KANSAS:

Section 1. That the Governing Body approves and hereby adopts the 2024 budget amendments for the Sewer Fund, Solid Waste Fund, Bond & Interest Fund, and the Mayor's Charity Fund as reflected in the Summary of Amendments, attached as Exhibit A.

Section 2. That this resolution shall become effective upon passage.
