




So, though the paper was actually "zero years old," it was "year one" for the new publication. It currently reads "Vol. 140" so The Star is actually 139 years old.

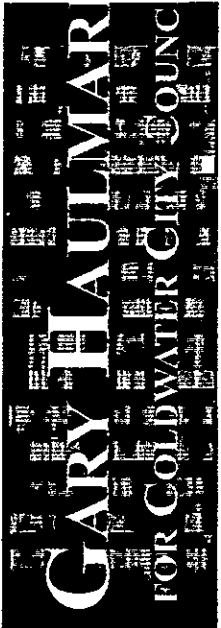
Over the years, either accidentally or intentionally, the week that the volume number got changed was moved back to August 1. That's where we keep

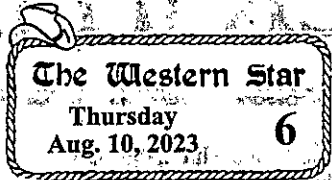


