Our adjusted price is based upon the following assumptions:

- 1. An ADP of 10,550.
- 2. Physicians, mid-level practitioners, and psychiatrist being moved to non-essential positions. All other positions remain as classified in the RFP.
- 3. A **\$7.5 million** annual cap on Hepatitis-C medications. Any amounts in excess of this cap are the financial responsibility of the KDOC.

We were able to reduce our price to \$85.5 million assuming a \$6.5 million limit on medications relating to Hepatitis C. With a \$7.5 million limit, our price changed to \$86.5 million.

Separately, we are concerned with being overly aggressive in our price given the long-term uncertainty of the impact of Covid-19 on healthcare needs. While the price is intended to address the financial expectations of the KDOC, we would like to continue our discussion of the appropriate change in scope and termination provisions of the contract.
