Article 5-1; Bridging Documents Discussions

Article 5-2; Interviews

- A. Interviews will be held on **Tuesday, October 25.**
 - a. Interview Room: Landon State Office Building (LSOB), 900 SW Jackson Street, Topeka KS, Room 509
 - b. Waiting Room prior to Interview: LSOB Room 560. This room will be open to occupy until you are notified that interview room is available.
