The request of George Vega, Director of the Division of Personnel Services, to authorize the Kansas Commission on Veterans' Affairs to reassign two unclassified registered nurses to the Registered Nurse Senior class at pay step 18 and to assign an unclassified licensed practical nurse to the Licensed Practical Nurse Senior class at pay step 18, effective November 16, 2008, is hereby approved.
