### 2016 Ad Valorem Tax Levies

The levies listed are the official 2016 ad valorem tax levies established by the Sedgwick County Clerk, and County Clerks of adjacent counties for joint taxing subdivisions with territory in this county. The rates thereon are expressed in mills, or dollars per one thousand dollars of assessed valuation.



ALL TAXES ARE DUE NOVEMBER 1, 2016.  
 The first half taxes may be paid on or before December 20th, 2016, and second half taxes may be paid on or before May 10, 2017. Statements in the amount of \$10.00 or less must be paid in full. First half taxes become delinquent on December 21st, 2016, and second half taxes become delinquent on May 11th, 2017.
