Re: Quarterly Update

The following quarterly report reflects the Civil Service Board case filings and action taken between January 15, 2018 and April 19, 2018:

A. Cases Filed Between January 15, 2018 and April 15, 2018:

B. Cases Decided and/or Disposed of:

3-day Suspension

affirmed

Department of Corrections, Lansing Correctional Facility

Corrections Officer I. Appellant received a 3-day suspension for making inappropriate and unprofessional remarks to the mother of an inmate and wife of another employee while on duty as security patrol. The Board affirmed the action of appointing authority.

Demotion/Whistleblower

reversed

Department of Labor

Public Service Administrator II. During the reorganization of the Call Center, the appellant was "transferred" from a management position to a data input position in the Records Management Division. Appellant's pay and job classification remained the same. This position required skills that the appellant did not possess. Appellant believed the move was a demotion, so he filed an appeal with Board. He later added a claim under the Kansas Whistleblower Act. While the appeal was pending, the appellant was subjected to a layoff in the Records Management Division. The Board initially dismissed the appeal as untimely. Ultimately, the appeal was remanded back to the Board by the Kansas Court of Appeals. The Board found that the appellant established that the move was a demotion

and was unreasonable. KDOL was ordered by the Board to reinstate the appellant to a position at the same job classification and pay in the same or similar position with the same or similar duties. The Board found that the appellant did not establish that there had been a violation of the Kansas Whistleblower Act.

4-day Suspension

withdrawn

Board of Indigents' Defense Services

Administrative Assistant. Appellant was suspended for four days for conduct including accessing and reading documents from mail boxes of other office members; ongoing rude behavior for which she had received previous "Consultation Reports" back to 2002; and speaking negatively in the office about a client of the office and other matters. Appellant withdrew her appeal.

Demotion

modified

Department of Corrections, Lansing Correctional Facility

Corrections Officer I. Appellant was demoted for inserting another employee's name in a custody classification record as the creator of the record, without permission of the employee. Appellant then also approved the custody classification. The Board found that the appellant established that the demotion was unreasonable. The Board modified the discipline to a 5-day suspension.

5-day Suspension

dismissed

Kansas Department for Aging and Disability Services/Kansas Neurological Institute

Client Training Supervisor. Appellant was suspended for 5-days for failing to follow KNI/Employee policies and for exhibiting sub-standard leadership/behavior towards staff. Prior to the hearing, KDADS withdrew the suspension.
