EXECUTIVE DIRECTIVE NO. 07-381

Authorizing Personnel Transactions

By virtue of the authority vested in the Governor as the head of the Executive Branch of the State of Kansas, the following transactions are hereby authorized:

The request of George Vega, Director of the Division of Personnel Services, to reassign the Enforcement Agent, Securities Special Investigator I, and Fire Investigator job classes to pay grade 28, the Securities Special Investigator II class to pay grade 30, and provide a wage increase equivalent of two steps to employees in these classes, or approximately 5.0 percent, is hereby approved, effective June 17, 2007.

The request of George Vega, Director of the Division of Personnel Services, to provide a 2.0 percent wage increase for the following job classifications at the Kansas Highway Patrol: Highway Patrol Trooper, Highway Patrol Master/Technical Trooper, Highway Patrol Lieutenant, Highway Patrol Captain, Highway Patrol Major, Law Enforcement Officer I and Law Enforcement Officer II (only Motor Carrier Inspector employees with full law enforcement authority), and Law Enforcement Officer III (Motor Carrier Inspection Sergeant), is hereby approved, effective June 17, 2007.

The request of George Vega, Director of the Division of Personnel Services, to provide Fire Prevention Inspector and Fire Prevention Specialist employees a wage increase equivalent to a two-step increase, or approximately 5.0 percent, is hereby approved, effective June 17, 2007.

The request of George Vega, Director of the Division of Personnel Services, to change the title from Capital Defense Investigator class to Investigative Agent is hereby approved, effective June 17, 2007.
