2025 Ad Valorem Tax Levies

The levies listed are the official 2025 ad valorem tax levies established by the Sedgwick County Clerk, and County Clerks of adjacent counties for joint taxing subdivisions with territory in this county. The rates thereon are expressed in mills, or dollars per one thousand dollars of assessed valuation.

ALL TAXES ARE DUE NOVEMBER 1, 2025.

The first half taxes may be paid on or before December 22, 2025, and second half taxes may be paid on or before May 11, 2026. Statements in the amount of \$10.00 or less must be paid in full. First half taxes become delinquent on December 23, 2025, and second half taxes become delinquent on May 12, 2026.
