EXECUTIVE DIRECTIVE NO. 04-349

Authorizing Expenditure of Federal Funds and Authorizing Personnel Transactions

By virtue of the authority vested in the Governor as the head of the executive branch of the State of Kansas, the following transaction is hereby authorized:

Pursuant to the authority of the Kansas Department of Commerce to receive and expend federal funds, and pursuant to the authority granted the Governor by Section 8(b) of Chapter 160 of the *2003 Session Laws of Kansas*, approval is hereby given to the Kansas Department of Commerce for expenditure in FY 2004 and FY 2005 of monies in the federal fund account entitled "Other Federal Grants Fund—USDA—AG Innovation Center."

I have conferred with the Director of the Budget and members of my staff, and I have determined that the guidelines set forth in KSA 75-3711 and 75-3711c have been applied and that none of the foregoing actions exceeds the limitations contained therein.
