

## **EXECUTIVE DIRECTIVE NO. 03-345**

### Authorizing Personnel Transactions and Authorizing Fund Transfers

By virtue of the authority vested in the Governor as the head of the executive branch of the State of Kansas, the following transactions are hereby authorized:

The request of Jack Rickerson, Director of the Division of Personnel Services, to establish the job classes Human Service Assistant at pay grade 15, Human Service Specialist at pay grade 21, Human Service Consultant at pay grade 24, Human Service Counselor at pay grade 26, Human Service Supervisor at pay grade 27 in the Kansas Civil Service is hereby approved, effective September 28, 2003.

The request of Jack Rickerson, Director of the Division of Personnel Services, to abolish the job classes Archivist I, Archivist II, Archivist III, Active Treatment Program Director, Alcohol/Drug Abuse Program Consultant, Child Support Enforcement Specialist I, Child Support Enforcement Specialist II, Child Support Enforcement Supervisor, Director Chaplaincy Service, Disability Examiner I, Disability Examiner II, Disability Examiner III, Disability Examiner IV, Disability Determination Program Director, Disability Determination Program Manager, Dental Hygienist, Dental Inspector, Dietetic Technician, Economic and Employment Support Specialist I, Economic and Employment Support Specialist II, Economic and Employment Support Supervisor, Foster Grandparent Project Director, Historic Preservation Specialist III, Historic Sites Administrator, Liquor Control Investigator, Long Term Care Case Manager, Long Term Care Staff Manager, Long Term Care Supervisor, Medical Record Administrator, Medical Record Technician, Medical Record Technician in Training, Museum Conservation Technician, Nutritionist I, Occupational Therapy Assistant, Occupational Therapist I, Orthotic/Prosthetic Technician I, Paleontologist, Physical Therapist I, Physical Therapy Aide, Program Support Worker, Psychology Trainee, Psychometric Technician, Registered Nurse I, Rehabilitation Specialist I, Rehabilitation Specialist II, Rehabilitation Counselor I, Rehabilitation Counselor II, Rehabilitation Manager I, Rehabilitation Manager II, Safety and Health Inspector I, Social Work Director, Social Worker Trainee, Speech Pathologist/Audiologist III, and Travel Attendant from the Kansas Civil Service is hereby approved, effective September 28, 2003.

I have conferred with the Secretary of Administration, the Director of the Budget, the Director of Personnel Services, and members of my staff, and I have determined that the requested actions are appropriate.

The request of Roderick Bremby, Secretary of the Department of Health and Environment, that \$732 from the State General Fund “Aid to Local Units for Family Planning” account (264-00-1000-4-0610-02); \$46,404 from the State General Fund “Aid to Local Units” account (264-00-1000-4-0350-02); \$50,000 from the State General Fund “Teen Pregnancy Prevention Activities” account (264-00-1000-4-0650-02); and \$5,932 from the State General Fund “Operating Expenditures (Including Official Hospitality)” account (264-00-1000-4-0202-02) be transferred to the State General Fund “Vaccine Purchases” account (264-00-1000-4-0900-02) is approved, effective immediately.

Pursuant to the authority of the Kansas Department of Agriculture to receive and expend federal funds, and pursuant to the authority granted the Governor by Section 77(b) of Chapter 138 of the *2003 Session Laws of Kansas*, approval is hereby granted to the Kansas Department of Agriculture for expenditure in FY 2004 of monies in the federal fund account entitled “Other Federal Grants Fund—FEMA—Flood Plain Mapping.”

I have conferred with the Director of the Budget and members of my staff, and I have determined that the guidelines set forth in KSA 75-3711 and 75-3711c have been applied and that none of the foregoing actions exceeds the limitations contained therein.
